I understand that such displacement carries no right of return to the home school and that I must accept all conditions for displacement and assignment which would have applied to other teachers being displaced. I am required to check my District e-mail on a regular basis (minimum weekly) for any updates or information regarding this process and/or my assignment.

I understand that I am being released from this school site effective _____ in accordance with the LAUSD/UTLA Agreement, Article XI, Section 6.0 (Displacement – Over – Teachered Schools) and that as provided in Article XI, Section 7.0, I will be placed on the District-Wide List for reassignment. This list will be distributed to principals District-wide who have vacancies in my subject area. Although every attempt will be made to return me to my geographical area, I am required to accept all calls and interviews from principals District-wide. I am free to send resumes and/or cover letters to schools of my choice that show vacancies on the HR website (or other schools in anticipation of future vacancies). At any time during the time I am on the Displacement List, I may be directed to report to any school in the District.

To facilitate my reassignment, I should also contact my Personnel Specialist at (213) 241-5100. I will continue to report to my current location until I have spoken with my Personnel Specialist and know where I will be re-assigned.
